To participate in it, please complete the attached form and mail, fax or email it to us. It is possible to participate in the integrated MBA and OSB program as one program with one mentor. You must enroll in both programs to be part of the integrated MBA and OSB mentor program; the MBA and OSB work together to match you with an appropriate, local mentor. There is no cost for the MBA program, but you must pay the required OSB fee. You may participate in the MBA mentor program only.

The goal of our mentor program is to provide a valuable resource for new lawyers during their first several years of practice. Your mentor will assist you in:

1. learning about local legal rules (written and unwritten) and culture,
2. creating a networking opportunity, to ease your entry into your local legal community,
3. traversing some of the professional and ethical challenges you may face as a novice practitioner, particularly in the area of professionalism, and
4. integrating the MBA program with your OSB mandatory mentor program, if applicable.

Mentoring provides a unique opportunity for new lawyers to partner with, and learn from, highly-respected and seasoned local lawyers. The MBA Mentor Program is open to all MBA YLS members.
